THE STORES ARE OPEN TO THE PUBLIC AND THE ITEMS THEY SELL ARE SIMILAR TO WHAT YOU MAY FIND IN OTHER HOME GOODS STORES, SUCH AS A BRAND NEW BOX OF TILE YOU'VE BEEN NEEDING FOR YOUR BATHROOM PROJECT OR A VINTAGE TREASURE YOU WON'T FIND ANYWHERE ELSE. HOWEVER, HABITAT RESTORES ARE MORE THAN JUST RESALE STORES. THE RESTORE IS A VITAL SOURCE OF REVENUE TO SUPPORT RICHMOND HABITAT'S WORK. THEY ARE LARGE ENOUGH FOR THE HOMEOWNER FAMILY'S NEEDS, BUT SMALL ENOUGH TO KEEP CONSTRUCTION AND MAINTENANCE COSTS AFFORDABLE. STUDIES SHOW THAT STRONG AND STABLE HOUSEHOLDS ARE FOUNDATIONAL TO CHILD DEVELOPMENT AND GROWTH.
